I ALSO UNDERSTAND THAT THE APPRAISER MUST BE A CERTIFIED GENERAL REAL ESTATE APPRAISER AUTHORIZED TO PERFORM REAL ESTATE APPRAISALS IN THE STATE OF TEXAS AND MUST BE APPROVED BY THE CITY, IN THE CITY'S SOLE DISCRETION.

I UNDERSTAND THAT AFTER THE CITY RECEIVES THE APPRAISAL FROM THE INDEPENDENT APPRAISER, I WILL BE UNDER NO OBLIGATION TO PURCHASE THE NARROW STRIP OF CITY-OWNED LAND ABUTTING MY PROPERTY. I ALSO UNDERSTAND THAT REGARDLESS OF WHETHER I DECIDE TO PURCHASE THE NARROW STRIP OF CITY-OWNED LAND THAT ABUTS MY PROPERTY, THE APPRAISER'S FEE, ONCE PAID, IS NON-REFUNDABLE.
