# NOTICE OF PUBLIC HEARING ON TAX INCREASE

*This notice only applies to a taxing unit other than a special taxing unit or municipality with a population of less than 30,000, regardless of whether it is a special taxing unit.*

PROPOSED TAX RATE: \$0.5424 per \$100

NO-NEW-REVENUE TAX RATE: \$0.5293 per \$100

VOTER-APPROVAL TAX RATE: \$0.5424 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for City of Granite Shoals from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval tax rate is the highest tax rate that City of Granite Shoals may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Granite Shoals is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON 08/26/2025 06:00 PM (CT) at City Hall, 2221 North Phillips Ranch Rd, Granite Shoals, TX

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Granite Shoals is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of City of Granite Shoals at their offices or by attending the public hearing mentioned above.
